

TERMS AND CONDITIONS OF THE NTO MINTING PROGRAM

These **TERMS AND CONDITIONS OF THE NTO MINTING PROGRAM** are entered into by and between each registered or unregistered end user (each, a “**Minter**”, “**User**”, “**You**” or “**Your**”) and Charism LLC of Suite 336, Beachmont Business Center, Kingstown, St. Vincent and Grenadines, registration number 1999 LLC 2022, a limited liability company creating and existing under the laws of Saint Vincent and Grenadines (“**Choise.com**”, “**Company**”, “we” or “us”).

The following terms and conditions, together with any documents they expressly incorporate by reference (“Terms of NTO Minter Program”), govern your access to and use of NTO Minter Program located at <https://nto.choise.com/> or such other URL as may be designated by the Company from time to time, as well as any mobile apps or other related services or applications thereto (collectively, the “NTO Minter Program”).

“Important notice”: We reserve our right to change, cancel, suspend, or modify any aspect of the NTO Minter Program at any time and at our sole and absolute discretion, taking into account the user’s benefits and rewards earned. You agree it is your responsibility to follow and review any such changes. We will notify you of any changes via our webpage becoming effective on the day of their publication. It shall be considered that you agree with the changed NTO Minter Program if you continue to participate in the NTO Minter Program Program after the changes become effective.

1. Each registered or unregistered end user (suitable for the conditions described in paragraph 3) is able to join NTO Minter Program on the following rules stipulated herein.
2. Please read these Terms of the NTO Minter Program carefully before you start to participate in NTO Minter Program. By clicking to accept or agree to these Terms of NTO Minter Program when this option is made available to you, you accept and agree to be bound and abide by these Terms of NTO Minter Program. If you do not agree to these Terms of the NTO Minter Program you must not participate in NTO Minter Program.

3. The NTO Minter Program is offered and available to users who are of legal age (i) in Saint Vincent and Grenadines (16 years or older) and (ii) in the users' jurisdiction or place of residence. By participating in NTO Minter Program, you represent and warrant that you (i) are 16 years of age or older in Saint Vincent and Grenadines, (ii) are of legal age in your jurisdiction or place of residence, (iii) not barred to participate in NTO Minter Program under any applicable law, order, directive, regulation, or sanction list and (iii) are participating in NTO Minter Program only for a lawful purpose. If you do not meet these requirements, you must not participate in NTO Minter Program.
4. The NFT provides you with the opportunity to create (or as we call it, mint), a non-fungible token ("Choby NFT") by using your digital assets.
5. For being NTO Minter you must be registered in NTO Minter Program and mint the Choby NFT, which will be transferred to your wallet provided by the Company.
6. All the conditions under which you mint Choby NFT you may see on the screen of your device before you get access to NTO Minting Program. Acceptance of these conditions is strictly necessary for using the NTO Minting Program. By placing your digital assets into NTO Minting Program, you signify your acceptance and agreement with these conditions.
7. We may, in its sole and absolute discretion, terminate, restrict, or suspend any user's participation in the NTO Minter Program for breach of these Terms of the NTO Minter Program.
8. In the case of reselling NFT Choby minted by you on the secondary market you will receive 3% as a royalty.
9. Special promotion campaigns may apply from time to time which may define different rewards and/or conditions as valid for the set period. In such cases and under the conditions and for the period as defined in such special promotions, the terms of such special promotion apply.
10. You are personally responsible for the payment of taxes that are mandatory in Your jurisdiction in connection with the Choby NFT and NTO Minter Program.
11. You acknowledge that participating in NTO Minter Program does not create a partnership, joint venture, or legal relationship of any kind between you and the
